<sup>(1)</sup> Regular Members.

a. corporations, other business organizations and any institutions with official seat (in Dutch: statutaire zetel) in the Netherlands; b. corporations or other business organizations with official seat in Japan, in which a majority of the voting rights is exercised by a corporation or other business organization with official seat in the Netherlands or by an individual or individuals of Netherlands nationality;

c. individuals of Netherlands nationality who are residents of Japan and represent or are employed with a corporation, other business organization or institution as referred to under Article 4(1) paragraph a. or paragraph b.

<sup>(2)</sup> Associate Members.

a. corporations, other business organizations and any institutions that do not belong to any of the categories referred to under Article 4(1) paragraph a. or paragraph b. and that seek business and/or friendship relationships with Regular Members or otherwise actively contribute towards realization of the objects of the NCCJ;

b. individuals of other than Netherlands nationality that seek business and/or friendship relationships with Regular Members or otherwise actively contribute towards realization of the objects of the NCCJ;

c. individuals of Netherlands nationality that do not belong to the category referred to under Article 4(1) paragraph c.
